Selectmen's Meeting
August 12, 2014

Wayne Miller called for the Pledge of Allegiance at 6:00 pm and then called the meeting to order.

Wayne made a motion to accept the minutes of July 22, 2014. Kristin Venza 2nd the motion; it was passed 2-0.

Report of officers and committees:

Animal Control Officer- Jacqueline Frye:

The Animal Control Officer reported stated there was one call last month, a barking dog.

CEO- Eric Gulbrandsen:

Eric Gulbrandsen reported that several Building Permits were issued, Ronald Leavitt, Andrew Roy, Frank Berry and Deborah Khiel.

Lori asked about roadside mowing and Wayne said he thought it was too late this year as the seeds have already dropped. It needs to be done beginning of July.

The Selectmen discussed missing road signs. The Tapawingo Road post is up and sign needs to be put up. Two other signs needed to be ordered and Wayne said he would order them.

Admin. Assistant – Diana Curtis (DJ):

A MMA insurance form was signed by Wayne.

DJ discussed with the Selectmen the Troy Morse letter and winter road contract.

DJ and the Selectmen discussed audit and money needed from surplus. The Town will have to have a Special Town Meeting to request money needed for accounts listed in audit as well as shortage in 2014 Legal account.

Old Business:

Lori mentioned that she had a meeting with Brian Molloy, Peter Malia and Al Perry to discuss winter road issues.

New business:

Received an application for town hall rental from the Sweden Volunteer Fire Dept.

Alberta left a note saying that we need cups to put on chairs in town hall. Wayne will get cups necessary for the chairs.

Received three applications; Kim Ashley, DJ and Lynn Hurd for the Treasurer's Position. The Selectmen reviewed applications. Lori mentioned she would like to interview applicants for the position and will set up appointments for the next Selectmen's meeting. Wayne reminded her that he would not be able to attend that meeting and that to hold interviews in executive session.
