Corin Meehan discussed the 2015 proposed budget. There are a couple of changes. 1.) Operations and safety will increase from \$750 to \$1,000. This increase will cover 2-4 firefighter classes. 2.) Corin is adding a line item for \$400 to cover cost of training materials. 3.) They have a new pay system that eliminates the per-call stipend and

reflects an hourly pay rate of \$10. This is a reflection of the "cost of doing business" that is incurred on volunteer/call firefighters. The fire department is looking to appropriate \$10,000 a year for 10 years to begin a plan for replacement of department apparatus. The proposed budget for 2015 with \$10,000 of Capital Improvement is \$35,430. Wayne Miller asked Corin why there were not any fuel slips with the statement from WEX. Corin stated that WEX puts all the information on the statement. Gallons, date and code for driver.
