Road Commissioner – Stephen Bennett:

Lori said that Stephen wanted to know what the Selectmen thought about Marr Road and Clough Hill Road that are not being maintained. Wayne said Clough Hill Road was abandoned. Stephen would like to put sand and gravel down and cut bushes back on Marr Road. Wayne said they would need to look up the status of the roads and that the files were in the back-storage room. That part of Marr Road may also be abandoned to maintenance.

Wayne mentioned that the little ridges of snow on the roads after plowing were caused by snow plows driving too fast. Lori said she would tell Troy.
